Indiana ANFP Chapter Updates—Summer 2024

What is always consistent is change and ANFP has a lot of new information and processes that affect both the national organization and chapter organization. We will try to highlight those for you. For additional information please refer to the Association of Nutrition and Foodservice Professionals (ANFP) website.

Crowded

ANFP has transitioned to central banking through a platform called Crowed. What this means is that of August 31st, all chapter funds including Indiana have been transferred to a central bank into a software platform called Crowded. This new banking system is done to increase security on all chapter funds and allow smooth transitions of chapter leadership. It will also provide enhanced reporting and accountability for chapter funds. All members will be required to use the Crowded application to register for chapter meetings. If you have not downloaded that application, you can find it in the App Store on your I-phone and register. Please refer to the instructions on Page 4 of this newsletter for further instructions. If you plan to attend the September 27th Event, you can register through the Crowded app.

Indiana ANFP Policy and Procedure Update

ANFP has written new policies for all chapters to utilized. Those policies are not available yet, but will be sometime during the fourth quarter. This change is being done to provide consistency for managing chapters throughout the country. While financial, officer job descriptions and other administrative policies will be consistent, Indiana will have the ability to have chapter specific policies. It is expected that these policies will be introduced to the members during the fourth quarter of 2024. Once available, we will send those out for members review and will be available on the Indiana ANFP Chapter Portal on the ANFP Website. Indiana ANFP has rewritten our annual awards and these policies will be included in the new policy manual. More information awards later this year but it is our hope to present awards at our spring meeting at Das Essenhause in May of 2025.

ANFP Mobile App

As I-phones and Ipads are becoming increasing popular, ANFP information can now be access on your mobile devises through the Association of Nutrition and Foodservice Professionals application that can be downloaded to you devise through the App Store. 
Spring Meeting—April 30 through May 2, 2025 Essenhaus Inn and Conference Center, Middlebury, Indiana

Welcome to Crowded

ANFP's New Online Banking System

Over the next few months, ANFP will be converting their banking system for all state Chapters to a new platform called Crowded. The new platform will be fully operational by August of 2024. At that time, all chapters will turn over their state funds to a centralized banking system. Each chapter will have their own portal and the funds are extremely secure.



Indiana ANFP was selected to be one of the test sites. For the fall meeting in Greentown Indiana, all registrations will be made through Indiana's Crowded Platform. All members will be able to download the application on their cell phone or mobile devise. Once the app is downloaded, simply complete the registration to activate and account All events will be listed in your personal account and you will be able to pay direct-



ly into the system with your credit card or debit card. A confirmation will be sent directly to your email for reimbursement purposes. It is fast, easy and secure!

ROOTS Roundup

Welcome to the Summer 2024 edition of ROOTS Roundup! In this newsletter you will read about what is happening at ANFP Headquarters, updates from Craig Brightup; ANFP's Washington DC representative, and valuable information you can share with your state chapter and leaders.

Continuing their service on the Government Affairs committee are Barbara Thomsen, CDM, CFPP as Chair, Cindy Cothern, CDM, CFPP, Dave Kahn, Amarylis Saluk, CDM, CFPP, Jeffery Wuollet, CDM, CFPP and newest member Mark Riley, CDM, CFPP. This committee is responsible for Developing and implementing comprehensive and effective government affairs strategies for the association on the Federal and state levels.

Continuing their service on the ANFP PAC committee are Dorothy Radermacher as Chair, Karla Klein, CDM, CFPP, Marjorie Smith, CDM, CFPP, Raven Marchino, CDM, CFPP and newest member, Jesus Osorio, CDM, CFPP. This committee is responsible for assisting the Government Affairs committee in the development and implementation of effective government affairs strategies and recommends the disbursement of funds from the ANFP-PAC in concert with current legislative strategies.

The U.S. Dept. of Education (ED) has revised minimum hour requirements for approved training programs to be eligible for Title IV financial assistance. New requirements are from the Oct. 31, 2023, final rule "Fiscal Responsibility, Administrative Capability, Certification Procedures, Ability to Benefit (ATB)," which amend regulations for Title IV of the Higher Education Act.

Starting July 1, 2024, to be eligible for Title IV financial assistance, training programs must adhere to amended gainful employment regulations at 34 CFR §668.14(b)(26), which specify programs can't require hours exceeding the greater of either the institution-stated didactic and field experience minimums or the minimums required by the State to qualify for Title IV funding. The ANFP program is offered in fifty schools nationwide and requires a minimum of 120 didactic and 150 field hours, but many approved schools exceed the minimums. As of July 1, those schools and their newly enrolled students will not be eligible for Title IV financial assistance unless their hours are pared back to match ANFP's minimums or the State's, whichever is greater.

The proposed FY2025 Prospective Payment System for SNFs published by CMS on April 3 also included requests for comments on potential changes to the malnutrition code and nutritional approaches for residents; the Quality Reporting Program concerning food; and the Value-Based Purchasing Program. ANFP submitted comments on these topics to CMS in May.

ANFP Washington Representative Craig Brightup attended a May 8 lunch for Congresswoman Jen Kiggans, who saluted National CDM, CFPP Day with remarks she made in the Congressional Record, and a July event for Kiggans is being planned for which ANFP-PAC support will be requested.

ANFP-PAC is integral to our visibility and success on Capitol Hill. ANFP-PAC can now accept association member contributions electronically via an FEC-compliant system to facilitate donations at ANFP's live meetings and other events. ANFP-PAC had \$8,5334 cash-on-hand as of May 31, 2024, and the goal is to reach \$10-15,000.
