THE GOLD STANDARD FOR CERTIFICATION IN FOODSERVICE MANAGEMENT

I'm writing to let you know that our records indicate you have **reported all of** your CE hours for your three-year recertification cycle ending May 31, 2024.

Please keep in mind that individuals who have met all CE requirements may be randomly selected for CE Audit. If you are randomly selected, you will be notified by email on June 3rd to the e-mail address on file in your ANFP record. All selected individuals will be required to take all stated actions to pass the CE Audit. If you are not selected for CE Audit, your next recertification period will begin immediately on June 1, and you will receive an email on June 4 confirming that you were not selected for CE Audit.

If you are randomly selected for CE Audit your record will automatically go into Pending Review. CBDM will begin to review records in Pending Review on June 3 and will complete this process by July 31. Throughout this period, you will receive emails from CBDM and/or your CE auditor regarding the status of pending hours or required documentation needed to meet recertification and CE Audit requirements.


